# **Joining Process**

- Prospective members are required to complete a membership application form (included in this brochure). Once completed, a current member of Titirangi Golf Club must nominate you for membership. If a prospective member does not know any existing members, please make contact with our golf office so introductions can be made.
- . Once your application is completed and nominator has signed the application, you will submit your application to the golf office or electronically to gm@titirangigolf.co.nz
- 3. We encourage prospective members to visit the club and play a round of golf with either your nominee or another member of the course. Our golf shop team can help make these arrangements for you.
- 4. A meeting with the General Manager and/or Club Captain may be requested prior to final acceptance of your application.
- 5. Upon acceptance of your membership, you will either be admitted into the category for which you have applied or placed on the waiting list for that category. Upon acceptance into a category, a joining fee is to be paid and the first year's annual subs will become due. Upon payment, you will receive a welcome pack to the club and you can begin to enjoy all the benefits of membership at Titirangi Golf Club.

### D. Payment Terms

#### Joining Fee:

- 1. Joining fee can be paid either payment in full or over a **two** year period. Once membership is accepted the whole of the joining fee invoice is liable regardless of future resignation of the membership.
- 2. If the Applicant wishes to use our payment plan, a payment plan agreement will be forwarded to you. Acceptance of a payment plan agreement is at the sole discretion of the Club. A Direct Debit authority is required for the payment plan.

#### Annual Fees:

- 1. Annual fees are due upon receipt of the invoice. Payment can be made in full at the time of invoice or via a 10 month payment plan. Once invoiced the whole invoice is liable regardless of resignation during the season.
- 2. If the Applicant wishes to use our payment plan, a payment plan agreement will be forwarded to you. Acceptance of a payment plan agreement is at the sole discretion of the Club. A Direct Debit authority is required for the payment plan.

#### Joining Fee Discounts:

- 1. Women receive a 90% discount to the joining fee at present
- 2. Under 35s receive a 60% discount to the joining fee at present

Discounts are subject to change at the Club's discretion.

#### E. Terms & Conditions

- 1. If the Applicant's application is accepted, the Applicant will be deemed to be a "Member" of the Club for the purposes of all Conditions of this application and Rules of the Club with effect from the payment of the Invoice.
- 2. From the Commencement Date, the Member will be bound by and will comply with the Club Rules as adopted by the Club and/or amended by the Club from time to time. Failure to do so may result in suspension of membership privileges and/or termination of the Membership of the Club.
- 3. This application is to be governed in accordance with New Zealand law. All disputes are subject to the Club's constitutional processes.
- 4. Payment of the fee's associated with this Application are due upon receipt of the Club's Invoice. Non-payment of the invoice will cancel this application.
